MOTORCOACH ITINERARY

Saturday, November 7:

5:30am: Motorcoach will depart from Lancaster, AC Moore Store located in Lancaster Shopping Center on the Oregon Pike/ Route 272 side of the store.

6:30am: Depart from Harrisburg, AAA Central Penn, 2301 Paxton Church Rd; travel to Finger Lakes, NY with a rest stop en route.

Arrive in Watkins Glenn for a tasting and lunch at **Castel Grisch Winery and Restaurant**. Next, visit the **Pleasant Valley Wine Company**, popularly known as the Great Western Winery, one of the oldest wineries in the Finger Lakes region where we will enjoy a tasting and tour. Established in 1860, the winery proudly displays the designation U.S. Bonded Winery No. 1 and has eight remarkable stone buildings listed on the National Register of Historic Places. Next we depart to the **Finger Lakes Beer Company** for a flight of beer. Then check into the hotel with time to freshen up before departing for a three course demo dinner and wine tasting at **New York Wine and Culinary Center**. Here dinner is not just a meal, it is an experience.

Hotel: The Inn on the Lake, Canandaigua, NY (Lunch, Dinner)

Sunday, November 8:

After a hot breakfast buffet at the hotel depart for another day of tastings. First stop is at **Three Brothers Wineries** where we can experience tastings of cider, three wineries, and a microbrewery. As we head south, we stop at **Ventosa Vineyards** for a hot lunch buffet and tasting. After lunch we will visit both the **Seneca Shore Wine Cellars** for a tasting and the **Abandon Brewing Company** for a flight of beer. Depart for Central PA after a delightful dinner buffet at **The Bullfrog Brewery**. (Breakfast, Lunch, Dinner)

PAYMENT
